A ROAD TEST APPOINTMENT WILL BE MADE FOR YOUR CONVENIENCE

Simply check off your preference at the bottom of this form. The road test will be conducted in the same kind of car (with the dual brake) that is used in driver education and administered by a DMV examiner.

The fee for the road test service is \$129.00 (with a 15 minute warm up), or \$159.00 (with a full 45 minute lesson) just prior to the test. Please make checks payable to East Meadow Driving School. Payment will confirm your appointment REQUESTS FOR REFUNDS MUST BE MADE AT THE TIME OF NOTIFICATION OF THE DATE OF THE SCHEDULED TEST.

Please note that requests for changes in the date or time may cause a delay of 5 to 6 weeks in the test date.

**Students must have their permit for at least 6 months before eligible to take the NYS DMV road test. Appointments are made once that waiting period has expired.

TRANSPORTATION

Your child will be picked up from their school, transported to the road test site, and returned to the school by an instructor.



The fee is \$249 for the package, a \$125 deposit is required when handing in this form. Please make checks payable to East Meadow Driving School. Payment will confirm your appointment. YOU WILL BE CALLED ONCE YOUR APPOINMENT HAS BEEN MADE. REQUESTS FOR REFUNDS MUST BE MADE AT THE TIME OF NOTIFICATION OF THE DATE OF THE SCHEDULED TEST.
